



# Buckeye Community Health Plan Quick Reference Guide for Ordering Physicians

**EFFECTIVE, NOVEMBER 1, 2014**

Buckeye Community Health Plan has selected National Imaging Associates, Inc. (NIA) to provide radiology network management services. NIA will provide utilization management services for **outpatient** MR, CT, CCTA, PET, Nuclear Cardiology/MPI, Stress Echocardiography, and Echocardiography imaging procedures. NIA will manage the prior authorization of non-emergent, advanced, outpatient high technology radiology services rendered to Buckeye members.

**The ordering physician is responsible for obtaining a prior authorization for advanced radiology services.** It is the responsibility of the rendering facility to ensure that prior authorization was obtained. As the ordering physician of advanced diagnostic services, it is essential that you develop a process to ensure that the appropriate authorization number(s) has been obtained. Payment will be denied for procedures performed without a necessary authorization, and the member cannot be balance-billed for such procedures.

## Procedures Requiring Prior Authorization Under Buckeye Community Health Plan \*

- CT/CTA
- CCTA
- MRI/MRA
- Pet Scan
- Nuclear Cardiology/ MPI as of 11/1/14
- Stress Echocardiography as of 11/1/14
- Echocardiography as of 11/1/14

\*A separate authorization number is required for each procedure ordered.

## The following services do not require authorization through NIA:

Emergency room, observation and inpatient advanced radiology services

If an emergency clinical situation exists outside of a hospital emergency room, please contact NIA immediately with the appropriate clinical information for an expedited review. The number to call to obtain a prior authorization is 1-866-246-4359.

## Prior Authorization Process

There are two ways to obtain authorizations -- either through NIA's Web site at [www.RadMD.com](http://www.RadMD.com) or by calling 1-866-246-4359.

## Information Needed to Obtain Prior Authorization

To expedite the prior authorization process, please have the following information ready before logging into NIA's Web site or calling the NIA Utilization Management staff. (\*Information is required.)

- Name and office phone number of ordering physician\*
- Member name and Buckeye ID number\*
- Requested examination\*
- Name of provider office or facility where the service will be performed\*
- Anticipated date of service (if known)
- Details justifying examination.\*
  - Symptoms and their duration
  - Physical exam findings
  - Conservative treatment patient has already completed (e.g., physical therapy, chiropractic or osteopathic manipulation, hot pads, massage, ice packs, medications)
  - Preliminary procedures already completed (e.g., x-rays, CTs, lab work, ultrasound, scoped procedures, referrals to specialist, specialist evaluation)
  - Reason the study is being requested (e.g., further evaluation, rule out a disorder)
- Please be prepared to fax the following information, if requested:
  - Clinical notes
  - X-ray reports
  - Previous CT/MRI reports
  - Specialist reports/evaluation
  - Ultrasound reports

## Web Site Access

- It is the responsibility of the **physician ordering the imaging examination** to access NIA's Web site or call for prior authorization. Patient symptoms, past clinical history and prior treatment information will be required and should be available at the time of the contact.
- Web site hours of operation are Sunday through Friday, 5:00 a.m. to 12:00 a.m. EST and Saturday 8:00 a.m. to 1:00 p.m. EST. You can obtain prior authorizations through NIA's Web site at [www.RadMD.com](http://www.RadMD.com). To begin, you will need to obtain your own unique user name and password for each individual user in your office. Simply go to [www.RadMD.com](http://www.RadMD.com), click on the New User button and complete the application form.
- If requesting authorizations through [www.RadMD.com](http://www.RadMD.com) and your request is pended, you will receive a tracking number and NIA will contact you to complete the process.
- The NIA Web site cannot be used for retrospective or expedited authorization requests. Those requests must be processed by calling 1-866-246-4359.

## Telephone Access

Call center hours of operation are Monday through Friday, 8 a.m. to 8 p.m. EST. You may obtain a prior authorization by calling 1-866-246-4359.

- NIA can accept multiple requests during one phone call.

## Important Notes

- Authorizations are valid for 30 days from the date of final determination.
- The NIA authorization number consists of eight or nine alpha/numeric characters. In some cases, you may instead receive an NIA tracking number (not the same as an authorization number) if your authorization request is not approved at the time of initial contact. You can use either number to track the status of the request on the RadMD Web site or via our Interactive Voice Response telephone system.
- For prior authorization complaints/appeals, please follow the instructions on your denial letter or Explanation of Payment (EOP).

NIA's guidelines for the use of imaging examinations have been developed from practice experience, literature reviews, specialty criteria sets and empirical data.
- An authorization number is not a guarantee of payment. Whether the requested service is covered is subject to all of the terms and conditions of the member's benefit plan, including but not limited to, member eligibility, benefit coverage at the time of the services are provided and any pre-existing condition exclusions referenced in the member's benefit plan.
