

## Payment Policy: Add-On Code Billed Without Primary Code

### Policy Overview

The purpose of this policy is to explain the parameters for add-on codes submitted on physician claims. The American Medical Association (AMA) defines add-on procedures as those procedures “always performed in addition to the primary service or procedure and must never be reported as a stand-alone code.” Add-on codes reported as stand-alone codes are not reimbursable services in accordance with Current Procedural Terminology (CPT) and the Centers for Medicare and Medicaid Services (CMS) guidelines.

The CPT manual designates add-on codes with a "+" symbol. The code descriptor of an add-on code often contains terms like "each additional" or "List separately in addition to primary procedure," according to the AMA.

### Application

This policy applies to outpatient professional claims (applicable within same claim and across claims history for the same date of service and same provider).

### Reimbursement

The Health Plan follows the AMA and CMS with respect to the reporting of add-on CPT and HCPCS codes. Code editing software evaluates claim lines on the current claim and in claims history for the presence of an add-on code billed with a primary code. If an add-on code is billed and the primary code is not present on the current claim or a claim in history, the service line is denied. Furthermore, if a procedure code is billed with an add-on code and the primary procedure code is present but has been denied for another reason, the add-on code will also be denied.
